A REPLAT OF BLOCKS 1,2,3,4,5,7,8,9 &11 FLORIDA CITY HOMESTEAD ADDITION

AS RECORDED IN PLAT BOOK 32, PAGE 1, PUBLIC RECORDS OF DADE COUNTY, FLA. IN SECTION 24, TOWNSHIP 57 SOUTH, RANGE 38 EAST, FLORIDA CITY, FLORIDA

KNOW ALL MEN BY THESE PRESENTS:- That the Town of Florida City, a Municipal Corporation organized and existing under the laws of the State of Florida and owner of Blocks 1,2,3,4,5,7,8,9 and II according to Plat of Florida City Homestead Addition as recorded in Plat Book 32 at Page I of the Public Records of Dade County, Florida, has caused to be made the attached plat entitled "BRYAN H. EDWARDS MUNICIPAL PARK"

The purpose of this Plat is to convert Blocks 2,3,4,5,8,9 and II of said plat and the intervening streets into two acreage tracts as shown entitled TRACT A and TRACT D for Park purposes and to convert Blocks I and 7 according to said plat into acreage tracts entitled TracT B and TracT C

The Streets and Avenues as shown together with all existing and future planting, trees and shrubbery thereon are hereby dedicated to the perpetual use of the Public for proper purposes reserving to the Town of FLORIDA CITY, its successors and assignes, the reversion or reversions thereof whenever
